1. 03/18/18, officers assisted the Colorado State Patrol with a traffic accident near the 124 mile-mark of Highway 50.
2. 03/19/18, officers responded to a reported possible forest fire near the 84 mile-mark of Highway 149. No fire was detected and it was assumed that it may have been an unregistered controlled burn.
3. 03/19/18, officers and ambulance was dispatched to an address near County Road 48 for a male who had fallen from a roof. The patient was transported to the Gunnison Valley Hospital.
4. 03/19/18, officers served a 33-year-old Gunnison County female with an arrest warrant while she was in custody on a non-related matter. The warrant charges her with menacing in a domestic violence circumstance which is a class 5 felony. She was also charged with reckless endangerment which is a class 3 misdemeanor. There is a no bond stipulation to the domestic violence charge.
5. 03/20/18, officers assisted the Gunnison Police with a theft circumstance at a business within Gunnison.
6. 03/21/18, officers responded to an address near Ute Lane for a reported disturbance. Subsequent to an investigation a 38-year-old male was arrested on the charges of domestic violence, harassment and child abuse. The individual was taken into custody without incident. This is a no-bond charge.
7. 03/22/18, officers received a report concerning theft from within a residence. Officers are following leads; case remains open.
8. 03/22/18, North District officers were dispatched to an address within Marble for an unattended death; initial investigation reveals that suicide was likely. This case continues to be investigated.
9. 03/23/18, officers arrested a 19-year-old Minnesota male on the charges of 3rd degree criminal trespass, illegal possession of marijuana by an underage person, driving while under the influence of drugs, and possession of open container of marijuana. The arrest was made near County Road 17 and went without incident. The bond for the violation is set at \$750.

10. 03/24/18, officers conducted a civil assist at a residence West of Gunnison.
11. 03/25.18, officers received a report concerning a possibly lost family near South Beaver Creek. The family was found and redirected.

1. 03/08/18, officers arrested a 52-year-old Gunnison County male on the charges of violation of a protection order, possession of a firearm by a previous offender, and violation of bail bond conditions. Bail bond is set at \$10,000.
2. 03/11/18, officers received a complaint of sexual harassment concerning juveniles. This case continues to be investigated.
3. 03/12/18, officers cited a 60-year-old Gunnison County female for allowing her dog to run at large. The animal was running out into traffic on West Highway 50.
4. 03/12/18, officers were dispatched to 6 miles north of Gunnison on Highway 135 for a report concerning someone lying on the highway. Officers were unable to locate the individual.
