1. 04/01/18, officers received a report concerning criminal mischief at an address near County Road 721 (Soap Creek Road). This case continues to be investigated.

1. 03/21/18, officers cited a 51-year-old female for obstructing a peace officer and obstructing government operations.
2. 03/27/18, Gunnison Community Services officers collected a dog that was running at large within the city of Gunnison and discovered that the animal had been reported as missing to the Gunnison County Sheriff's Office a year ago. The animal and the rightful owner were reunited.
3. 03/27/18, officers arrested a 51-year-old Gunnison female on the charges of criminal attempt, assault in the 1st degree, assault in the 2nd degree, and menacing. Bond for these offenses is set at \$50,000.
4. 03/29/18, North District officers assisted federal agencies with executing a search warrant at a residence within Gunnison County.
5. 03/29/18, North District officers dealt with a large mud slide near the 44 mile-mark of Highway 133.
6. 03/29/18, officers found a dog wondering near Highway 135 2 miles North of Gunnison. The dog was taken to the Gunnison Valley Animal League Shelter for safe keeping. The owners were located.
