1. 04/22/18, officers arrested a 27-year-old Gunnison County male on the charges of 2 counts of assault in the 2nd degree (class four felonies), 1 count Menacing (class five felony), and domestic violence in the felony range.
2. 04/24/18, officers responded to a reported assault that took place at an address near County Road 76. Investigations revealed that a crime had taken place and subsequently a 25-year-old Gunnison male was arrested for second degree assault with a \$5,000 bond.
3. 04/24/18, officer responded to a remote location north on Soap Creek for a distress call. Park Service and other emergency Services responded. It was discovered that the late evening message had been sent accidentally.
4. 04/25/18, officers arrested a 40-year-old Gunnison County male for 2nd degree assault after investigating a neighbor disagreement at an address north of Gunnison. The bond for the violation is set at \$25,000.
5. 04/25/18, officers were dispatched to an address west of Gunnison for a possible domestic violence situation. Investigations revealed that elements of criminal activity did not exist. However, a 28-year-old male was taken into protective custody for an alcohol commit.
6. 04/26/18, officers responded to an address near County Road 13 for a prowler call.
7. 04/26/18, at approximately 3:09 am, officers responded to a disturbance call at an address near County Road 17. Subsequent to an investigation a 26-year-old Gunnison County male was arrested for possession of an unlawful controlled substance. Bail for the offense was set at \$2,000.
8. 04/26/18, officers assisted the Gunnison Police with an emergency commit issue.
9. 04/27/19, North District officers were advised of a grassland/forest fire on Jumbo Mountain just West of the Delta/Gunnison County lines; south of Highway 133 by a couple miles. The fire is reported to be about 50 acres in size, all in Delta County; part on private land and part on BLM. The fire started on private land and is related to a control burn that got out of hand. This location is described as rugged terrain, scrub oak and some dead and dying aspen. As of 04/30/18, the fire is fully contained.

10. 04/27/18, at about 10:30 am, officers responded to the Hartman Rocks area for a load noise complaint from residence near the staging area. Music was turned off and a warning was extended.
11. 04/28/18, officers responded to a barking dog complaint in the upper Castle Mountain area. A warning was extended through the wishes of the reporting party.
12. 04/28/18, officers conducted a civil standby on Reed Street in Gunnison.
13. 04/29/18, officers received notification that criminal mischief took place to County property on County Road 743. This case continues to be investigated.
14. 04/30/18, officers assisted the Gunnison Police with a disturbance on North Colorado Street.
15. 04/30/18, officers responded to a medical call near Monte Vita Way.
