1. 04/09/18, officers received a weed sprayer that was found by a citizen in Almont.
2. 04/09/18, officers assisted the Colorado State Patrol with a DUI investigation one North on Highway 135.
3. 04/10/18, officers concluded an investigation concerning a telephone harassment episode. Through the wishes of the victim a warning was extended.
4. 04/09/18, an officer accidentally struck a rock with his patrol vehicle near the 20 mile mark of County Road 742. The vehicle was towed for repairs.
5. 04/11/18, officers investigated a report concerning a possible protection order violation. Sound evidence could not be established and a warning was extended.
6. 04/11/18, officers responded to Pitkin regarding a disorderly male; the issue had been resolved by the time officers arrived.
7. 04/12/18, officers received a report concerning a burglary at a residence near the Jack's Cabin Cutoff; case continues to be investigated.
8. 04/12/18, officers responded to a report of a vehicle in the River with a non-responsive driver. Investigations revealed the vehicle was simply stuck on the sand near the river and the occupants were unharmed.
9. 04/13/18, officers assisted the Colorado State Patrol with numerous vehicles which had slid off of Highway 50 (around the 120 to 123 mile mark) due to slick conditions.
10. 04/15/18, officers responded to an address near east Highway 50 for a medical related call.
11. 04/16/18, officers responded to an address North of Gunnison for highly intoxicated male. The individual was transported by ambulance to the Gunnison Valley Hospital for treatment and observation.
12. 04/16/18, officers are looking into a complaint concerning a possible stalking issue.
13. 04/17/18, officers arrested a 40-year-old Crested Butte male on two no-bond warrants out of the Gunnison County Court for bail bond violations and protection order violations.
14. 04/17/18, officers responded to a reported tree that had blown down across County Road 742.

15. 04/17/18, officers were able to prevent a couple from starting a campfire on a red flag day. A verbal warning was extended.
16. 04/17/18, officers assisted the Gunnison Police with an assault report.
17. 04/17/18, officers received a report concerning possible elderly abuse. Human Services were contacted and an investigation revealed that the concern was unfounded.
18. 04/18/18, North District officers investigated a vicious dog report concerning a dog that attacked another dog. This case continues to be investigated.
19. 04/19/18, officers received a complaint concerning fraudulent deception. Officers were able to establish that this is a scam where money was exchanged and financial damages were sustained.
20. 04/21/18, officers responded to a car-deer accident 6 miles north of Gunnison on Highway 135. Both the deer and the vehicle were incapacitated.
21. 04/21/18, while assisted the Colorado State Patrol with a DUI arrest a passenger of the vehicle was also arrested on the charge of violation of a protection order. The 30-year-old Montrose male was arrested without incident; the bond is set a \$1,500.
22. 04/23/18, officers found a dog that was wandering around near the North edge of Gunnison and returned the animal to the rightful owner.
23. 04/23/18, officers conducted a civil assist at an address north of Gunnison.
24. 04/23/18, officers investigated a trespass call north of Gunnison and a warning was extended.
25. 04/23/18, officers responded to an address near Rio Vista Way for a trespass concern. The complaint was concluded without charges.
