1. 05/29/18, officers received a report concerning a stolen license plate from a camper trailer in the Taylor Park area.
2. 05/29/18, officers responded to a single vehicle rollover accident near County Road 27.
3. 05/29/18, a cell phone that was found on the 25th was returned to the rightful owner.
4. 05/29/18, officers responded to an address near Silver Sage Lane for a medical call.
5. 05/30/18, officers responded to a civil dispute at a location near Rocky River Lane. No criminal activity took place.
6. 05/30/18, Sheriff's Officers assisted the Lakewood Police Department with contacting a Gunnison County resident about a death in their family.
7. 05/31/18, officers received a report concerning criminal mischief at the Dos Rios Golf Course.
8. 05/31/18, officers responded to a business near County Road 11 for a trespass issue. The circumstance was taken care of without charges.
9. 05/31/18, officers assisted the Gunnison Police Department with a trespass issue at the schools.
10. 05/31/18, officers assisted the Gunnison Police with a disturbance near the east edge of Gunnison City Limits.
11. 06/01/18, officers received a report concerning a 15-year-old male who was being treated for minor injuries that he received when he had an accident on an ATV while riding on BLM. The youth was treated and released from the Delta Hospital.
12. 06/01/18, officers became aware that there is an active scam that has resurfaced. The suspects will search local media, (newspapers, shopper, etc.) for items that a potential victim is advertising for sale. They contact the victim by phone or text and arrange to purchase the item. Within short period of time the victim will receive a check that has an amount much larger than the agreed upon price. The scammer will then instruct the victim to deposit the check and send the scammer back the overage in the form of a certified check, money order or gift card. The suspect's plan is to take advantage of the victim's sense of good faith. The victim is urged by the scammer to comply with due haste. Such timely compliance will create a circumstance in which the suspect will receive the "refund" before the victim is aware that the scammer's original

check is bad. If at any point you feel that you may be a potential victim of a scam, contact law enforcement before participating.

13. 06/01/18, officers assisted the United States Park Service with a disturbance at the Elk Creek Marina.
14. 06/01/18, officers responded to a single vehicle accident near the 11 mile mark of County Road 742.
15. 06/02/18, officers responded to a campground west of Gunnison regarding a disturbance. By the time officers arrived things had settled and no one wanted to press charges.
16. 06/03/18, officers assisted the Gunnison Police with a potential trespass issue on South Wisconsin Avenue.
17. 06/03/18, officers responded to Pitkin regarding a disturbance.
18. 06/03/18, officers responded to a medical call at a local restaurant for a male that was choking. The victim recovered and did not need further medical assistance.
19. 06/04/18, at around midnight, officers were dispatched to the Steven's Creek Campground for a welfare check on a suicidal individual. Mental Health professionals took over the circumstance.
20. 06/04/18, officers were dispatched to a traffic accident nine miles North of Gunnison on Highway 135. The vehicle was abandoned; case continues to be investigated.
