1. 06/10/18, officers assisted the Gunnison Police on a drug interdiction issue. This case continues to be investigated.
2. 06/11/18, officers received a report concerning harassment. This case continues to be investigated.
3. 06/11/18, officers assisted federal agents in making an arrest at the probation office.
4. 06/11/18, officers responded west of Gunnison on Highway 50 for a report of "bloody rags" in the middle of the highway. Investigations revealed that it was an elk carcass.
5. 06/11/18, officers were called regarding suspicious activity at residents near Highway 50. Investigations revealed that it was a door to door salesman.
6. 06/11/18, officers assisted the Gunnison police with a disturbance near the 600-block of North Colorado Street.
7. 06/12/18, officers assisted the National Park Service with arresting a 64-year-old Boulder male on the charges of driving a vehicle with an obscure plate and obstructing a police officer. Bond for the charges was set at \$1,500.
8. 06/12/18, officers received a report concerning possible theft. Investigations revealed the issue is civil.
9. 06/13/18, officers assisted the National Park Service with suspicious activity near the Dam.
10. 06/13/18, officers returned a lady's wallet that was found by a citizen.
11. 06/13/18, officers investigated a fender bender accident on private property near Willow Trail.
12. 06/13/18, officers conducted a civil standby at a business in Taylor Park.
13. 06/14/18, officers responded to a business within Taylor Canyon for a reported disturbance. Officer conducted a civil standby.

20. 06/15/18, at approximately 1:00 am, officers arrested a 39-year-old Gunnison County female for domestic harassment and violation of a protection order at an address west of Gunnison. The United States Park Service assisted in the arrest. The charges allow no bond until the accused is advised by a judge.
21. 06/15/18, officers received a report concerning a dog bite case. Investigations revealed that the 40-year-old male victim was also the owner of the animal and that he determined that the bite was not with vicious intent.
22. 06/15/18, officers responded to an address near Blackfoot Trail for an illegal controlled burn. The fire was small and a warning was extended.
23. 06/15/18, officers responded to an address near Chinook Trail for a bon fire violation. A warning was extended.
24. 06/16/18, officers are investigating a criminal mischief report at a business west of Gunnison.
25. 06/16/18, officers cited a juvenile on a learner's permit for driving 20 to 24 miles an hour over the posted speed limit and driving with only other juveniles in the vehicle.
26. 06/17/18, officers arrested a 36-year-old Lake City male on a no-bond warrant out of Pueblo County. The arrest took place at a residence near County Road 27, Gunnison.
27. 06/17/18, officers assisted the Gunnison Police with a disturbance on North Colorado Street.
28. 06/18/19, officers investigated a welfare concern of a male who was in transit. The individual was subsequently transported for an emergency commit and psychological assessment.
