1. 06/16/18, a patrol vehicle struck a deer 7 miles north on Highway 135. Major damage was reported to the front of the car and the deer was a total loss. The Colorado State Patrol investigated the accident.
2. 06/19/18, officers received a report concerning fraudulent charges on a debit card. The car number was used in Illinois.
3. 06/19/18, officers responded to the White Water Park for a vicious dog report. Investigations revealed that a dog was killed by a Great Dane. When officers arrived the suspect animal and responsible party had left. This case continues to be investigated.
4. 06/19/18, officers arrested a 35-year-old Lake City male for a violation of condition pertaining to a protection order and a felony warrant out of Gunnison County Court relating to failure to comply with a court order. The total bond for the charges is \$3,000.
5. 06/19/19, officers received a report concerning a hiker that may have been suffering from heat exhaustion in the Illinois Creek area. The Western Mountain Rescue team was alerted and the 44-year-old Clearwater, Florida male returned in good health.
6. 06/19/18, officers responded to a location North of Gunnison regarding a trespass.
7. 06/20/18, North District officers responded to a four car accident on Highway 133. There were several injured a one air lifted from the scene. The Colorado State Patrol is investigated the accident.
8. 06/20/18, officers cited a 64-year-old Cedaredge male for reckless driving and menacing in a reported road-rage incident west of Gunnison.
9. 06/20/18, officers arrested a 47-year-old La Junta male for being in control of a motorized vehicle while under excessive influence of alcohol. The car he was driving also displayed fictitious license plates. The arrest took place at the Gunnison Cemetery while officers were conducting a welfare check of a man reportedly hunched over a steering wheel. Bond was set at \$750.
10. 06/20/18, officers arrested a 28-year-old Mount Crested Butte female on a \$1,000 warrant out of Steamboat Springs Police Department.

11. 06/21/18, at approximately 12:40 am, officers responded to a medical call at an address near County Road 51. The 36-year-old male was transported to the hospital.
12. 06/21/18, officers were dispatched to the Doctor's Park area for a reported injured bicyclist.
13. 06/21/18, officers assisted the National Park Service with a theft investigation.
14. 06/21/18, officers assisted the Gunnison Police Department with a disturbance on North Colorado Street.
15. 06/21/18, North District officers responded to an assist request in Delta County for a barricaded individual in a car. Subject was eventually removed without incident.
16. 06/22/18, officers received a black purse that a citizen had found near the Lake Fork Bridge on Highway 50.
17. 06/22/18, officers responded to a location east of Gunnison regarding a horse that may have been hit by a car. The animal was never located.
18. 06/22/18, officers received a report concerning a suspicious vehicle in a locked subdivision. Case continues to be investigated.
19. 06/22/18, officers responded to County Road 25 for a bull that was caught in a cattle guard. The bull was removed with minor injuries.
20. 06/22/18, officers were dispatched to an address near Hartman Rocks Drive for a noise complaint.
21. 06/22/18, officers responded to the Almont Restaurant for a report concerning a traffic accident involving a single vehicle at that business. It was also reported that there were multiple injuries involved. The Colorado State Patrol investigated the incident. Two people were transported to the hospital with what was termed as critical injuries.
22. 06/22/18, officers received a report concerning a violation concerning a protection order. This case continues to be investigated.
23. 06/23/18, officers arrested a 36-year-old North Carolina male on a violation of probation warrant out of Gunnison County Court. The arrest was made at the Gunnison Valley Hospital and went without incident.
24. 06/23/18, officers received a report concerning a dog bite case. Investigations revealed that while the 42-year-old female victim was jogging near County Road 17, she was bit. She was treated at the Gunnison Valley Hospital and the 70-year-old male owner of the animal was extended a warning through the wishes of the victim.
25. 06/23/18, officers responded to the upper Taylor Park area regarding a reported violation of stage two fire restrictions. Investigations revealed that a folks from Denver were unaware of the no-campfire order. A verbal warning was extended.
26. 06/24/18, officers and fire responded to a fire call near Phelps lane. It was undetermined what caused the small blaze.
27. 06/25/18, officers received a report concerning a lost pistol. The reporting party believes that the firearm may have fallen out of his pickup when he stopped in Crested Butte or maybe at City Market in Gunnison.
