1. 07/12/18, officers responded to a disturbance at a residence north of Gunnison.
2. 07/13/18, officers assisted the Gunnison Police with a disturbance at a local bar.
3. 07/14/18, officers responded to the Blue Mesa Guest Ranch for a vicious dog complaint. Investigations revealed that a 58-year-old Montrose male was bit in the face. The individual was treated and released from the Gunnison Hospital. The owners of the animal left the guest ranch.
4. 07/15/18, officers responded to the Monarch Pass for a report concerning a violation of the fire restriction. Investigations revealed that a 26-year-old male transient had left a camp fire unattended while he began to hitchhike. Further investigations revealed that he had a failure to appear warrant out of Fort Collins. After he was arrested he was given a \$510 penalty assessment ticket for the fire violation.

9. 07/17/18, North District officers received a complaint concerning a protection order violation. This case continues to be investigated.
