1. 08/18/18, officers received a complaint of a disturbance at the Parlin Post Office. Investigations revealed that a criminal act had taken place and subsequently a citation for harassment was issued on 09/06/18 to a 23-year-old Ohio City male.
2. 08/25/18, at approximately 9:10 pm, officers responded to the Taylor Park area for a disturbance. Initial investigations established that a 70-year-old Ponca City, Oklahoma male was transported to the hospital for head injuries. Officers continue to sort out the facts of this case.
3. 09/04/18, officers received a report concerning a missing hunter in the Dollar Lake area. The 22-year-old Fort Carson male was located on the 7<sup>th</sup> in good health.
4. 09/04/18, officers received a report from an inmate declaring theft of his personal belongings at his residence while he was in jail. Investigations reveal that the issues are civil.
5. 09/04/18, officers received a burglary complaint at a seasonal residence within the Little Cimarron area. This case continues to be investigated.
6. 09/05/18, officers arrested a 39-year-old Gunnison County male on the charges of harassment (domestic violence), assault in the third degree (domestic violence). The arrest stemmed from an investigation that started on 09/03/18 near Ute Lane. The charges carry a no bond provision.
7. 09/05/18, North District officers received a complaint concerning menacing at a hunting camp near Minnesota Creek close to Somerset. Investigations revealed that the issues had been embellished by the reporting party and it was a simple employer/employee disagreement which resulted into a civil issue. The former employee was extended a warning for false reporting.
8. 09/05/18, officers responded to a location east of Gunnison on highway 50 for what was reported to be a possible domestic violence circumstance. Subsequent to the

investigation a 39-year-old Dillon, Colorado male was arrested on the charges of domestic violence, 3<sup>rd</sup> degree assault and criminal mischief. These charges have a no-bond stipulation.

9. 09/05/18, officers received a complaint concerning a crime of defrauding an innkeeper- case continues to be investigated.
10. 09/05/18, officers received a cluster of keys that were found near the Twin Bridges.
11. 09/05/18, officers received a report concerning a trespass issue on private property. Investigations revealed the area of concern was public land- case unfounded.
12. 09/06/18, officers cited a 70-year-old Pitkin male for 3<sup>rd</sup> degree criminal trespass for a complaint that was filed on July 29, 2018.
13. 09/06/18, officers served an arrest warrant and transported a 16-year-old female from Gunnison to a Grand Junction juvenile facility.
14. 09/07/18, officers arrested an 18-year-old Gunnison County male on the charges of a driving while under the influence of drugs, illegal possession of marijuana by an underage individual and failing to drive in a constant lane. Bond for the violation is \$750. The arrest was made on County Road 38.
15. 09/07/18, Officers received a report concerning dogs chasing deer near county road 16 and 19.
16. 09/08/18, officers conducted a welfare check at a resident who lives west of Gunnison.
17. 09/08/18, at 8:00 pm and then at 8:30 pm, and finally at 9:10 pm, officers assisted the Gunnison Police with a large, loud party near the 600- block of West San Juan Street.
18. 09/09/18, officers assisted the Aurora Police Department with an unreported stolen vehicle out of Gunnison. It was discovered that a Gunnison County Resident had parked his vehicle near Denver International Airport at a motel. While the victim was away the vehicle had been stolen and then abandoned. The victim in this instance had previously taken photographs of his vehicle, plate and vehicle identification number before leaving the state which greatly assisted in this investigation.
19. 09/09/18, officers assisted the Colorado State Patrol with a serious motorcycle accident on Highway 50 near the 119- mile mark.
20. 09/09/18, North District officers responded as assisting agency for a missing 5-year-old girl within Paonia. The child was found upset but in good condition. The child had just wander off.
