1. 09/03/18, officers received a report concerning a criminal mischief that took place at a resident north of Gunnison. A car had been damaged.
2. 09/06/18, a 23-year-old Gunnison County male received a summons for failure to yield a right-of-way to a stationary emergency vehicle and failure to insure vehicle.
3. 09/10/18, officers responded to an address north of Gunnison regarding a possible suicide. Investigations revealed that the report was unfounded.
4. 09/10/18, North District officers towed a vehicle that had been abandoned near the mile mark 43 of Highway 133.
5. 09/10/18, officers were contacted and requested to conduct a welfare check on an individual who lives north of Gunnison.
6. 09/10/18 officers were dispatched to a possible hit and run accident near Ute Lane.

10. 09/13/18, officers responded to a structure fire north of Gunnison near Sage Road. Investigations revealed that the blaze was started by a faulty electrical system on a flatbed trailer. Damage was extensive to a truck, two trailers, several ton of hay and a barn.

12. 09/13/18, officers responded to a campground south of Gunnison for a reported unattended death. Investigations revealed 71-year-old male passed away from natural causes.
13. 09/13/18, officers responded to an address near County Road 76 (Ohio City Road) for a report concerning a disturbance. Investigations revealed that although there were several involvements associated with the disturbance officers were unable to establish firm probable cause.
14. 09/13/18, officers arrested a 68-year-old Australian for failure to drive in a constant lane and DUI. The arrest took place near the 6 mile mark of Highway 135.
