1. 09/24/18, officers cited a 24-year-old Keystone female for careless driving in relationship of failure to yield for an emergency vehicle.
2. 09/24/18, North District officer arrested a 17-year-old Somerset male for probation violation and menacing. The arrest took place in Delta County.
3. 09/24/18, officers responded to a location on County Road 17 (Antelope Hills Road), for a medical call concerning a female possibly suffering a stroke.
4. 09/24/18, officers assisted in town with a natural gas leak near the 400-block west Tomichi Avenue.
5. 09/24/18, North District officers responded to a location near County Road 12 (Kebler Pass) for a lightning strike fire. Paonia fire was able to extinguish the .5 acre blaze.
6. 09/25/18, officers arrested a 21-year-old Gunnison male on a failure to appear warrant out of Gunnison County Court on the charge of false reporting. The suspect was also charged with speeding. Bond was set at \$750.
7. 09/25/18, officers arrested a 68-year-old Gunnison County female on the charges of DUI and driving with excessive blood alcohol content. The arrest was made approximately 7 miles north of Gunnison. Bond for the offense is \$750.
8. 09/25/18, North District officers arrested a 52-year-old Paonia male on a Delta County warrant for a protection order violation. The officers immediately turned the subject over to Delta authorities.
9. 09/25/18, officers assisted the Gunnison Police with suspicious activity involving juveniles.
10. 09/27/18, officers received a report concerning possible harassment but the reporting party declined to file charges.
11. 09/27/18, officers were dispatched to an address near County Road 17 (Antelope Hills Road) for a property line issue. This case continues to be investigated.

12. 09/27/18, officers assisted the Gunnison Police Department with an issue involving a potential missing juvenile; unfounded.
13. 09/27/18, officers responded to the 188 mile mark of Highway 50 for a truck that had to use the truck ramp.
14. 09/28/18, officers investigated a minor two-vehicle accident on a private drive 2.9 miles north of Gunnison. A 20-year-old Gunnison female received a ticket for driving without a valid driver's license.
15. 09/28/18, officers responded to an address near River Front Road for what was reported to be a possible domestic violence circumstance. Investigations revealed that there was no criminal act- the adults involved were only arguing.
16. 09/29/18, officers received a report concerning possible menacing, theft, criminal mischief and trespass at a business near Highway 92. This case continues to be investigated.
17. 09/29/18, officers responded to a brush fire within the Hartman's Rocks south of McCabe's Lane. The blaze was small and extinguished.
18. 09/30/18, officers assisted the Colorado State Patrol with transporting an arrestee from mile mark 154, Highway 50, to the Gunnison County Detention Center.
19. 09/30/18, officers receive a report concerning the theft of a laptop computer from a campsite.
