1. 11/03/18, officers received a report concerning criminal Mischief to a tractor that was parked north of Gunnison. Owner determined that "kids" caused the damage and opted to handle it out of court.
2. 11/14/18, North District officers were able to establish that there had potentially been a trespass issue in relationship to a complaint filed on 09/30/18 reference private property near County Road 12. Both parties elected to settle things through a civil process.
3. 11/14/18, officers arrested a 36-year-old Gunnison County male on a \$5,700 felony warrant out of Chaffee County.
4. 11/14/18, officers received a found cell phone and was able to locate the owner.
5. 11/14/18, officers investigated a civil concern relative to an eviction process at a location within Parlin.

9. 11/16/18, officers responded to the Almont area in regard to a suspicious circumstance relating to possible trespassing. Officers were unable to establish that a criminal act had taken place.
10. 11/16/18, at midnight, officers responded to an address near Candlelight lane for a medical call.
11. 11/16/18, officers assisted the Gunnison Police Department with a deer issue near the intersection of Loveland and Tomichi Avenue.

12. 11/17/18, officers cited a 10 year old male and by relativity, his mother with a charge of criminal mischief in relationship to damage sustained to a neighbor's window.
13. 11/17/18, officers investigated a 1st degree criminal trespass and theft complaint at an address near Highway 92. This case continues to be investigated.
14. 11/17/18, officers received a found wallet and are looking for the owner. The wallet was located on Flat Top Mountain.
