1. 11/24/18, North District officers received a report concerning theft. This case continues to be investigated.
2. 11/27/18, officers investigated a harassment complaint in Parlin. Investigations revealed the issues were civil and not criminal.
3. 11/27/18, North District Officers received a complaint in regard to fraudulent use of a debit card.
4. 11/27/18, officers responded to the Parlin area for a reported disturbance; no criminal activity; no charges were filed.
5. 11/28/18, officers arrested a 41-year-old Gunnison County male on the charges of unlawful possession of a controlled substance, unlawful use of a controlled substance, assault in the 3rd degree, driving under the influence of drugs, and domestic violence. A 31-year-old female was also arrested on the charges of unlawful possession of a controlled substance and unlawful use of a controlled substance. There was a no-bond stipulation for the male while the female's bond was set at \$2,000.
6. 11/28/18, officers responded to Highway 50, mile mark 144, for a traffic accident.
7. 11/29/18, officers arrested a 29-year-old Palmdale, California male on a \$500 Mesa County failure to appear warrant on former traffic infractions.
8. 11/29/18, officers assisted the Colorado State Patrol with an arrest on Monarch Pass.
9. 11/30/18, North District officers conducted a welfare assessment at a residence within Marble. While there they discovered a \$1,500 warrant out of Weld County Courts concerning a 56-year-old male who was also living at the same place. The suspect was arrested without incident.
10. 11/30/18, officers responded to the 6 mile mark of Highway 135 for a vehicle accident with a medical issue.
11. 12/01/18, officers investigated a minor traffic accident where a vehicle slid into mail boxes near County Road 38 (Gold Basin Road).

12. 12/01/18, officers assisted the Colorado State Patrol with an accident where a vehicle slid off Monarch pass. Although the accident disabled the vehicle the elderly female was hypothermic but was not injured.
13. 12/01/18, officers assisted the Gunnison Police with a reported domestic circumstance.
14. 12/02/18, emergency response was dispatched to mile marker 187 for a vehicle that was reported to be on fire- the concern was unfounded.
