
Drought Monitor Map






Drought Monitor Class Change


- Up to 1 to 3 class improvement has occurred in Gunnison County and the Upper Gunnison Basin in the past 10 weeks.

Gunnison County Precipitation Past 30 Days



Gunnison County Precipitation Past 7 Days




The next 7 days shows that no precipitation is forecasted except for small areas in northern Gunnison and Hinsdale Counties.

Median amount is 1.6" of precipitation and WY25 to date is currently 3.0"




Slumgullion Precipitation

Precipitation accumulation for WY25 is currently at 261% of the median








- Reservoir storage for the entire Gunnison Basin is currently at 55% of average.
- Reservoir storage for the Upper Gunnison Basin (Taylor and Blue Mesa) is at 54% of average.
- As of September 17, Taylor Reservoir was forecasted to end the water year at 63,068 acre-feet content which is 59% of average.
- In 2025, Blue Mesa ended the water year at 417,862 acre-feet which is 50% of capacity.

- Flaming Gorge – 82% full
- Fontenelle – 65% Full
- Morrow Point – 95% full





- Trappers Crossing Dspace & Emergency Ingress/ Egress thinning- 2025 (116 acres)-
\$502,000
- Trappers Crossing Dspace & Emergency Ingress/ Egress thinning - 2026 (1.8 miles of road & 10 Defensible Space Projects)-
\$429,000
- For every \$1 in mitigation, \$13 are saved in suppression, economic impact, and recovery costs.- U.S. Chamber of Commerce
