Tim Kugler (Committee Chair) called meeting to order Approval of September 2025 Meeting Minutes

There was not a quorum so the minutes could not be approved.

CPW presentation of Colorado Outdoor Strategy, *Tori Manogue and Jody Kennedy*

Manogue and Kennedy shared a presentation outlining the statewide outdoor strategy, which was designed to support recreation and wildlife through public outreach, partnerships, and improved access to tools and resources. Kennedy outlined core components focused on conservation, restoration, biodiversity, sustainable outdoor recreation, equitable access, and coordinated planning and funding. Their team will be working with a consultant to collect and map two years of data (2024–2025) on special-use sites. The strategy was intended to strengthen partnerships, support local committees, align statewide leadership, and encourage collaboration across public, private, and agricultural lands. They advanced this work through statewide training, coordinated partner efforts, collective strategies, and regional partnerships.

Manogue also reviewed grant opportunities, requirements, and planning elements that could align with the committee's long-term goals, noting available funding ranges for on-the-ground projects. She introduced online data and mapping tools available through Colorado's outdoor strategy, including the data dashboard, plan library, and CODEX, and explained how these resources could support future planning. The committee discussed opportunities to use these tools to assist STOR and emphasized the importance of mapping applications accurately reflecting ownership of public and private lands. Kugler continued to submit update requests as needed, and the committee discussed how changes were made across different platforms.

Kugler adjourned the meeting.
