A MOSQUITO CONTROL AREA AND ASSESSING A PORTION OF THE COST  
THEREOF AGAINST THOSE PERSONS ESPECIALLY BENEFITTED BY THE  
SERVICE BY RENUMBERING IT TO BE ORDINANCE NO. 11.a.**




