ORDINANCE NO. 9

**AN ORDINANCE AMENDING BOARD OF COUNTY COMMISSIONERS OF GUNNISON
COUNTY, COLORADO ORDINANCE NO. 8**

WHEREAS, pursuant to applicable authority the Board of County Commissioners of Gunnison County has duly adopted Gunnison County Ordinance No. 8 entitled "An Ordinance For The Regulation Of Traffic By Gunnison County, Colorado; Adopting By Reference The 1995 Edition Of The 'Model Traffic Code For Colorado Municipalities;' Repealing All Ordinances In Conflict Therewith; And Providing Penalties For Violation Thereof" (hereinafter referred to as "Ordinance 8"); and

WHEREAS, the Board of County Commissioners of Gunnison County, Colorado, deems it in the best interests of the citizens of Gunnison County and the general public for the Board to make certain amendments to said Ordinance No. 8;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF GUNNISON COUNTY, COLORADO:

Section 1. Ordinance No. 8 Amended. Ordinance No. 8 be and hereby is amended as follows: Section 4.C. shall read in its entirety:


"In addition to other penalties provided for by this Section 4, each person violating any of the provisions of this Ordinance or of the Model Traffic Code hereby enacted shall pay such surcharge as may be provided by statute or otherwise, and in all cases of a minimum of ten dollars (\$10.00), per violation. Such surcharge(s) shall be paid to the Clerk of the Court by the violator. The Clerk of the Court shall transmit the appropriate portion, as set by statute or otherwise, of the surcharge to the Court Administrator of the Seventh Judicial District for credit to the victims and witnesses assistance and law enforcement fund established in the Seventh Judicial District pursuant to C.R.S. Section 24-4.2-103 as it may be amended; the remainder of the surcharge shall be retained by the County Court of Gunnison County for the cost of administering this Ordinance. All surcharges heretofore transmitted to the Court Administrator, and not yet credited to such fund, shall be distributed by such Administrator pursuant to the above formula."


